Allen and Byron,

We have moved forward with removal of the word "qualified" from the text block. There are two major steps to this; change to the manual, and publish to the website. Internally the 556 manuals are either updated or will be in the next few days. The next step is publishing to the website. Our publisher has committed a timeline to get the manuals published by the end of January 2024.
